**Launch location:** Lake Point Park

**Creel and Length Limits:** 5 fish, 14" on Largemouth, 12" on Spotted  
Bass,.. Shoal Bass may not be in possession.

**TOURNAMENT WATERS:** The tournament waters for this event shall  
be Walter F. George (Eufaula lake) ONLY and shall include all waters  
creeks and canals connecting to the above-mentioned waters. Any  
waters within these boundaries posted Off-limits or No Fishing by  
State or Federal Agencies will be Off-Limits. Any live-bass-release  
areas established by the Tour Director will be Off-limits as well as will  
be announced at the pre-tournament briefing. Any additional off-limits  
will be announced at the Tuesday night pre-tournament briefing. Only  
that water open to ALL public fishing will be considered tournament  
waters. Any waters closed to public fishing will be closed to this  
tournament's contestants.

**License/permit fees:**

Walter F. George (Eufaula Lake) is a border lake between Alabama and  
Georgia. They have a reciprocal agreement which allows fishermen to  
fish the main lake of Walter F George with either an Alabama or  
Georgia license; however, this agreement does not apply to the  
tributary streams on either side of the lake. So by law you must have  
BOTH Alabama and Georgia Licenses if you get off the main lake for  
this event. **BOTH Licenses will be required for all contestants for  
this event.**
