Live wells must be empty.<br/>         All anglers are required to have a valid Colorado fishing license, Colorado State Park's Pass, &amp; a CDW Boat Inspection Tag.</p>   |
| <p><b><u>Fish Limits</u></b><br/>         Large, smallmouth, and spotted Bass 15" inches and over.<br/>         Anglers are allowed to weigh a limit of five (5) fish per team unless otherwise required by law or tournament officials.<br/>         Any fish presented for weigh-in which fails to measure the official length limits shall accrue penalties at the rate of one (1) pound for each non-legal fish plus loss of the fish.
