

# Sample Bylaws For A New TBF Junior Fishing Club

The sample club bylaws below are an example of what you need in your clubs bylaws. They are a starting point for your club to modify if necessary. Once your club has reviewed them and voted on a final copy. Please forward two (2) official copies to TBF with your club roster. Please note that the articles for "membership requirements" and for "affiliation" are required to remain in your bylaws for TBF to approve them and grant your club affiliation charter.

ARTICLE I - Name and purpose
Section 1: Name

Section 2: Purpose
The purpose of our TBF junior club is to promote and encourage youth fishing, we do promise to support TBF's founding principals, by creating among our fellow anglers and the public in general an awareness of the organization's contributions to American angling, conservation, and outdoor recreation through education, fishing ethics and techniques, sportsmanship, and conservation of our natural resources. We do pledge ourselves to full adherence to all conservation codes and to detect and report any polluter of our Nation's waters.
ARTICLE II - Membership
Section 1: Number of Members
The Chapter shall begin with and maintain at least six members to stay active.
Section 2: Requirements for Membership
To become a TBF Junior club Member, a person shall: Express an interest in membership and
be 18 years old or younger.
Section 3: Membership Dues
The dues shall be \$5.00 per member for TBF National Dues and \$ for club dues each

**Section 4: Meetings** 

The club shall hold regular meetings at pre-set times.

year. There may also be state dues as levied by the State Federation.

## ARTICLE III - Officers, Elections, Eligibility, and Vacancies

## Section 1: Officers and their duties

The officers of the club shall include:

- a. **PRESIDENT:** Will run all meetings and conduct all business with the guidance of an adult advisory member.
- b. **VICE PRESIDENT:** May run meetings, if the president is not present, and will assist president in all duties.
- c. **SECRETARY:** Take minutes of all meetings, keep rosters updated and take care of all correspondence and club mail.
- d. TREASURER: Collect all funds, record, and disburse all money of the club.

#### **Section 1: Elections**

The elections of officers shall be held annually. Elections shall be by majority of members present. Elections for each officer shall be held separately in order listed in ARTICLE III, section 1. Each member is entitled to one vote, proxy votes are not permitted.

#### **Section 2: Term of Office**

The term of office is for one year, which shall begin when elected, and end with the next year's election.

#### **Section 4: Vacancies**

In the event an office becomes vacant, an election shall take place to fill the position until the end of the term. If this happens, TBF National Office and your home state federation must be notified of the change in officers.

## **Section 5: Eligibility for Holding Office**

To be eligible for an office, a member must:

- a. have been a member for six months. (except for new club start-ups)
- b. have attended 50% of all club activities.
- c. have paid all dues.

## **ARTICLE IV - Removal Of Membership**

## Section 1: Causes for Removal or Suspension of Membership

A member can be dropped or their membership suspended from the club for any of the following reasons:

- a. failure to pay dues.
- b. failure to participate in 50% of club activities.
- c. any action that would dishonor and/or disgrace the club or TBF.

#### **ARTICLE V - Affiliation**

### **Section 1: Requirements for Affiliation**

- a. Approval of Junior Club by TBF National Office.
- b. Update your membership roster and all club members at least once each year before Dec 31.
- c. Send name, full address, and TBF dues of any new members joining your club as they join.
- d. Should be sponsored by an adult TBF club. If this is not possible. You may request an exception to policy from TBF National Office. Exceptions will be granted or not granted on a case by case basis.
- e. Must affiliate with your home State TBF Federation and support its programs.

# **ARTICLE VI - Method of Amending Bylaws**

# **Section 1: Amending the Bylaws**

The bylaws may be amended at any regular meeting by a majority of the members present. Members must be notified of the amendment two weeks in advance prior to voting on it.
