<u>Date</u> : Friday, November 15, 2024 <u>Registration Times</u> : 3:00 p.m. – Registration Opens 5:45 p.m. – Registration Closes. 6:00 p.m. – Mandatory rules briefing begins.	Take-off will begin at 7:00 a.m. or first safe light. Weigh-in starts at 3:00 p.m. Site Hosts	At time of inspection each morning, be prepared to properly display 1 life jacket for each angler; 1 throwable PFD; and, demonstrate functioning kill switch. Inspection will be held during lineup for takeoff. Live wells must be empty.

<u>Fish Limits</u>	Tournament Directors	<u>Boundaries</u>
Largemouth and smallmouth Bass 12" inches and over. Anglers are allowed to weigh a limit of five (5) fish per person unless otherwise required by law or tournament officials Any fish presented for weigh-in which fails to measure the official length limits shall accrue penalties at the rate of one (1) pound for each non-legal fish plus loss of the fish. An 8-ounce deduction will be made for each fish presented to the bump master for weighing that is determined to be non-releasable.
